- The show will be run according to FCEC & BRHF Rules.
 - a. All riders 18 and under must wear a helmet (ASTM approved) in mounted classes. Parent/Guardian responsibility to ensure helmet meets standards.
- The show is open to the public – you do not need to be a FCEC or BRHF member, but FCEC/BRHF guidelines still must be followed.
- Negative Coggins within twelve (12) months must be provided.
- Show management reserves the right to add, cancel or combine classes.
- Goodwill and sportsmanship are essential for a fun and safe show, management reserves the right to bar any animal, exhibitor, owner, or spectator for inappropriate behavior.
- Appropriate attire is encouraged, but not required.
- Neither leadership, or any affiliate of the Franklin County Equestrian Club (FCEC), nor any of its members, families, organizers, property owners, nor employees shall be held responsible for accident, damage, injury, illness, or loss to the animals, personal property, exhibitors, spectators, or any other persons on the show grounds.
- A two (2) minute gate call and five (5) minutes tack change will be enforced.

Directions to Ginther's Farm:

From Rocky Mount:

US 220 S turn left onto Route 619 Sontag Road (beside the 619 Minute Market) at the Traffic Light-go past the Parks and Rec. Dept. Ginther's Farm is on the right directly across from Sontag School-3128 Sontag Road, Rocky Mount, VA 24151-watch for the FCEC sign to turn in.

From Henry County:

US 220 N towards Rocky Mount turn right onto Route 619 Sontag Road beside the 619 Minute Market at the traffic light- go past the Parks and Rec. Dept. Ginther's Farm is on the right directly across from Sontag School-3128 Sontag Road, Rocky Mount, VA 24151-watch for the FCEC sign to turn in.

Parking for spectators will be available in Sontag Elementary School parking lot. Handicap parking with appropriate tag available at the Ginther's Farm.
