- The show will be run according to FCEC & BRHF Rules.
  - a. All riders 18 and under must wear a helmet (ASTM approved) in mounted classes.  
Parent/Guardian responsibility to ensure helmet meets standards.
- The show is open to the public – you do not need to be a FCEC or BRHF member, but FCEC/BRHF guidelines will be followed.
- Negative Coggins within twelve (12) months must be provided.
- Show management reserves the right to add, cancel or combine classes.
- Goodwill and sportsmanship are essential for a fun and safe show, management reserves the right to bar any animal, exhibitor, owner, or spectator for inappropriate behavior.
- Appropriate attire in encouraged, but not required.
- No stallions.
- Neither leadership, or any affiliate of the Franklin County Equestrian Club (FCEC), nor any of its members, families, organizers, property owners, nor employees shall be held responsible for accident, damage, injury, illness, or loss to the animals, personal property, exhibitors, spectators, or any other persons on the show grounds.
- A two (2) minute gate call and five (5) minutes tack change will be enforced.
- MUST be a member of FCEC, BRHF or VWRHOA prior to the show before points will count towards year end awards. ### Directions to Pinecrest Stables:

From Rocky Mount:

US 220 S towards Martinsville turn left onto Muddy Fork Road approximately five (5) miles ~ Pinecrest Stables will be on your right. Watch for Horse Show Signs!

From Henry County:

US 220 N towards Rocky Mount turn right onto Muddy Fork Road approximately five (5) miles ~ Pinecrest Stables will be on your right. Watch for Horse Show Signs!
